This is a notification of a meeting of the designated representatives of the City of Weslaco and Local 3207 of the International Association of Fire Fighters for the purpose of collective bargaining under Chapter 174 of the Texas Local Government Code. Meeting will be held in the Legislative Chamber of City Hall, Located at 255 South Kansas Avenue on Wednesday, October 28, 2020 at 4:30 pm pursuant to Section 551.045 of the Texas Open Meetings Act.

A temporary suspension of the Open Meetings Act to allow telephone or videoconference public meetings has been granted by Governor Greg Abbott. In conjunction with the guidance and provisions provided by the Governor and in order to advance the public health goal of limiting face-to-face meetings to slow the spread of the Coronavirus (COVID-19), there will be a **limit of twenty-five (25) in person attendance to include staff and the governing body.** These actions are being taken to mitigate the spread of COVID-19 by avoiding meetings that bring a large group setting and in accordance with Section 418.016 of the Texas Government Code. The meeting will be recorded and uploaded to the City website following the conclusion of the meeting.
