NOTICE IS HEREBY GIVEN THAT the City Commission of the City of Weslaco and the Weslaco Independent School Board of Trustees will hold a joint workshop at City Hall in the Legislative Room 255 S. Kansas on Thursday, February 18, 2021 at 5:30 p.m.

A temporary suspension of the Open Meetings Act to allow telephone or videoconference public meetings has been granted by Governor Greg Abbott. In conjunction with the guidance and provisions provided by the Governor and in order to advance the public health goal of limiting face-to-face meetings to slow the spread of the Coronavirus (COVID-19), there will be a **limit of twenty-five (25) in person attendance to include staff and the governing body.** These actions are being taken to mitigate the spread of COVID-19 by avoiding meetings that bring a large group setting and in accordance with Section 418.016 of the Texas Government Code. The meeting will be recorded and uploaded to the City website following the conclusion of the meeting.
