NOTICE IS HEREBY GIVEN THAT pursuant to Section 551.045 of the Texas Open Meetings Act the City Commission of the City of Weslaco, Texas will hold a Workshop on August 5, 2021 at the Weslaco City Hall, Legislative Chamber, located at 255 South Kansas Avenue, commencing at 5:30 p.m. for the purpose of discussing each departmental proposed budget for Fiscal Year 2021-2022.

A temporary suspension of the Open Meetings Act to allow telephone or videoconference public meetings has been granted by Governor Greg Abbott. In conjunction with the guidance and provisions provided by the Governor and in order to advance the public health goal of limiting face-to-face meetings to slow the spread of the Coronavirus (COVID-19), there will be a limit of seventy-nine (79) in person attendance to include staff and the governing body. These actions are being taken to mitigate the spread of COVID-19 by avoiding meetings that bring a large group setting and in accordance with Section 418.016 of the Texas Government Code. The meeting will be recorded and uploaded to the City website following the conclusion of the meeting.
