DECLARATION OF EMERGENCY STATUS TO
REPLACE EXISTING AERATION BLOWER**

This item seeks your concurrence and approval of the declaration of an emergency status to replace the existing aeration blower at the north wastewater treatment plant.

On Monday, November 6, 2023, at 3:00 PM, the existing aeration blower which provides air flow to the aeration basin and allows microorganisms to thrive and bio-degrade pollutants, stopped functioning. Inframark attempted to get the blower started by dismantling it and working on it to get it operational again. On Tuesday, November 7, 2023, at 7:00 PM, Inframark was able to get the blower functioning again. On this same day, Inframark had a lab collect a sample of the effluent for testing. The results of the testing are expected in approximately two weeks.

The existing blower must be replaced as soon as possible to avoid a very dangerous situation concerning the discharge of contaminated effluent which would be a violation of the Texas Commission on Environmental Quality regulations.

This is a matter of the utmost concern and I propose that it be declared an emergency. We must respond with urgency by proceeding with a quote to install the newly purchased blower that we recently received, in the bay next to the existing blower. Upon startup of the new blower, the existing blower could be shut down to afford us the opportunity to have it serviced by the manufacturer. In a prior meeting, you approved the purchase of an option to service the existing blower and we will call the manufacture to schedule the service as soon as possible.

If the blower were to fail during this time, we already have a quote for the rental and installation of a temporary blower to maintain the wastewater treatment plant functional. The rental company can get the blower going in one to two days. This would come at an initial cost of \$30,000.00 and a monthly fee of \$10,000.00.

Staff recommends approval of this item.

RESCIND RFQ FOR PROFESSIONAL ENGINEERING SERVICES
AND AUTHORIZE RFB FOR AERATION BASIN REPAIRS AND
REPLACEMENT OF HEADWORKS EQUIPMENT**

This item seeks your approval to rescind your authorization of a Request for Qualifications (RFQ) for professional engineering services for the study and design of improvements to the north wastewater treatment plant and authorize the solicitation of an RFB for aeration basin repairs and replacement of headworks equipment.

With the RFQ for professional services, the plan was to engage a qualified engineer to evaluate operations of the aeration process and to prepare plans for the installation of an aeration blower, aeration basin and headworks improvements.

However, due to the emergency replacement of the aeration blower this has prompted a change in plans. The existing aeration basin needs the replacement of the bubble aeration system, which is presently in critical condition and not functioning adequately. This makes the blower not operate efficiently and supply ample flow to certain zones of the basin. In addition, the basin has significant sludge buildup and needs cleaning.

As a result, our new plan is to issue a request for bids (RFB) to perform the required cleaning of the aeration basin and to replace the bubble aeration system that will ensure an efficient operation of the aeration process and not compromise the warranty of the new blower.

In addition, the RFB will also include the replacement of headworks equipment. The headworks equipment helps screen and process the influent stream by removing solids and debris. This increases capacity and efficiency of the treatment process.

Staff recommends approval of this item.
