Option #4

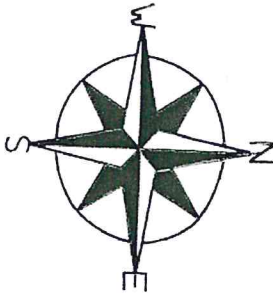
Change to Master fee schedule charge for 2nd interment. Fee to be ½ of 1st interment. (New Side Only)

YELLOW: SOLD

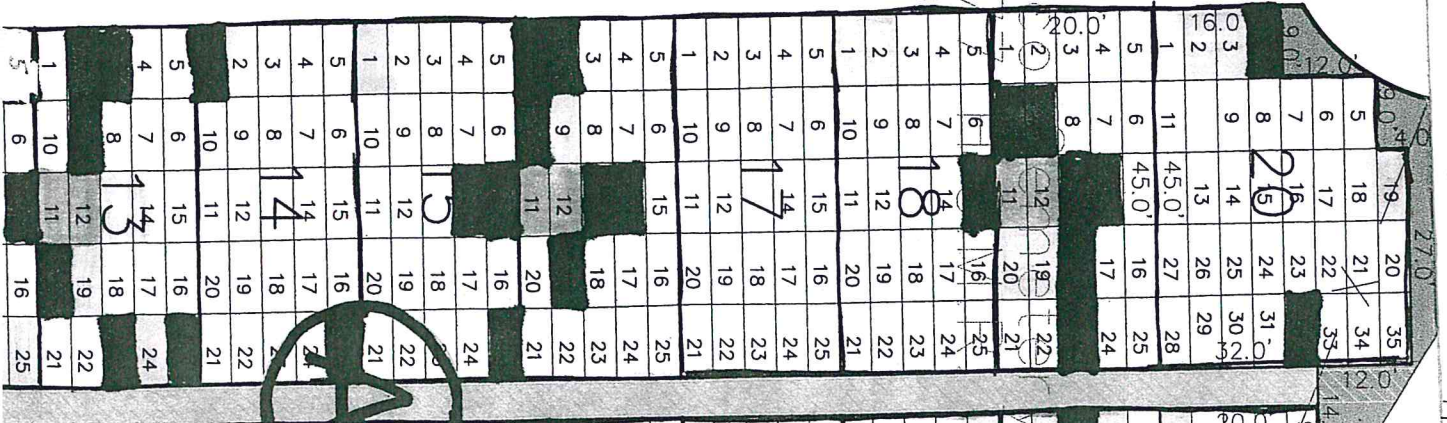
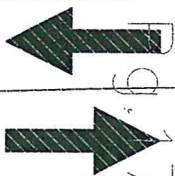
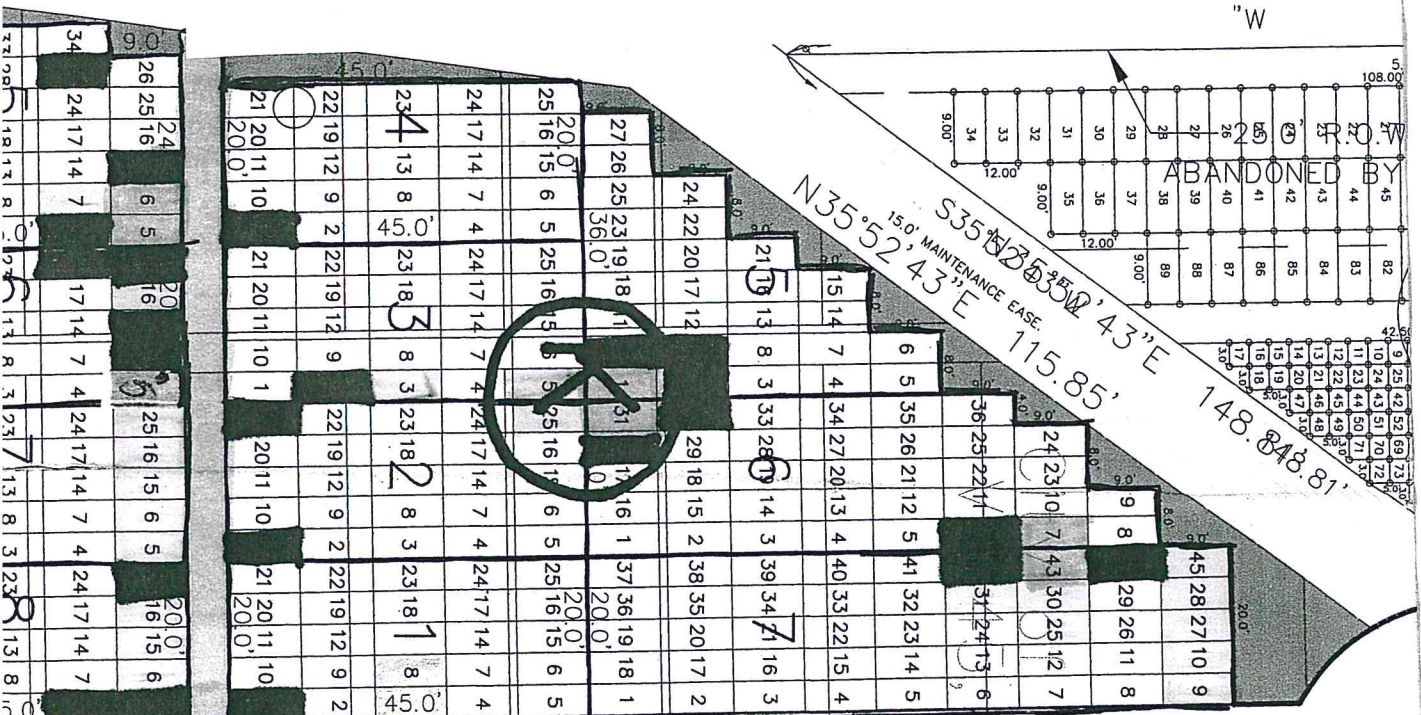
GREY: PYMT. PLAN
